25056: Highways matters:

1. Second VAS sign on Wheldrake Lane, Crockey Hill. Cllr E Hale has been in touch with CYC to find out what progress has been made on this issue – no new information.
2. 20 MPH speed limit in Deighton Village: Clerk already advised that this will not be progressed by CYC until the Local Plan has been completed.
3. Serious concerns about the speed of egress from Swan Farm Close onto Main Street and the possibility of an accident. Clerk reported this to Cllr Vassie who has forwarded the issue within CYC.
4. Cllr Bartram reported that both VAS signs at Deighton were operational.

1. Poppies – Cllr Bartram updated the Council on the purchase of poppies. These to be attached to lampposts within Deighton at a cost of £95. It was resolved, also that Cllr Bartram pay for these initially and can sign cheque to reimburse.
